- Go 2.0 miles and turn RIGHT onto NOKESVILLE RD / VA-28.
- Go 6.4 miles to 13909 Nokesville Rd. There will be balloons at the entrance.

From I-95 Northbound:

- Merge onto US-17 N via EXIT 133 toward WARRENTON.
- Go 24.6 miles and Turn RIGHT onto VA-28 / CATLETT RD. Continue to follow VA-28.
- Go 12.0 miles to 13909 Nokesville Rd. There will be balloons at the entrance.

From 522 Northbound:

- Merge onto JAMES MADISON HWY / US-15 N / US-29 N toward WASHINGTON.
- Go 13.4 miles and Turn RIGHT onto VA-28 / CATLETT RD. Continue to follow VA-28.
- Go 14.3 miles to 13909 Nokesville Rd. There will be balloons at the entrance.

From Prince William County Fairgrounds:

- Turn LEFT out of Fairgrounds.
- Go to the 2nd traffic light and turn LEFT onto HASTINGS DR (McDonalds on left).
- Turn LEFT onto NOKESVILLE RD / VA-28.
- Go approx. 6 miles to 13909 Nokesville Rd. on LEFT. There will be balloons at the entrance.
